Most Worshipful John Blair Jr.



"John Blair: The Man, The Mason, The Giant" is an engaging and enlightening program that explores the life and contributions of John Blair, Jr., a remarkable figure in American history. This program offers a comprehensive overview of Blair's jourhighlighting nev. his role as a Founding Father. Freemason. and influential jurist.

Born in Williams-

burg, Virginia in 1731, Blair hailed from a distinguished family. His father's prominent positions as the acting Royal Governor and Virginia Councillor shaped Blair's early exposure to public service. He became the Mayor of Williamsburg in 1751, showcasing his leadership capabilities from an early age.

Blair's political views evolved over time. Initially aligning with the moderate wing supporting the Patriot cause, he later changed his thinking during the dissolution of the House of Burgesses by Parliament. He collaborated with Booker T. Washington to draft non-importation agreements, aiming to cease the import of British goods until oppressive taxes were repealed. Blair also expressed solidarity with the residents of Boston and supported the call for the Continental Congress.

During the Revolutionary era, Blair's involvement in state politics intensified. He played a vital role in drafting Virginia's constitution, serving on committees responsible for shaping the government and Declaration of Rights. Additionally, he served on the Privy Council, advised Governor Patrick Henry, and held positions as a Judge in the general court and Chief Justice. Blair's deep commitment to Freemasonry was recognized when he became the Grand Master of Freemasons in Virginia in 1778.

Blair's exceptional legal scholarship earned him recognition from his peers. The Virginia Legislature appointed him to revise the state's laws, and he was later nominated by President George Washington to the United States Supreme Court. Blair served on the Supreme Court for six years before resigning, leaving behind a lasting legacy of profound influence.


